

#### **Wittman Farm Tours**

On November 6th, Congressman Rob Wittman and his team joined employees of Farm Credit and Virginia Farm Bureau for a tour of farms and agribusinesses in the Congressman's district. The farm tour began at Mattapony Reserve in West Point, a thriving winery on the Mattaponi reservation where they also serve delicious bison meat pies. They shared with Congressman Wittman the unique path they have taken due to challenges during covid and the importance of sustainable conservation practices.

Next, the group headed over to Riverwatch Farm, a family run operation where they raise adorable Nigerian dwarf goats. The family that runs the farm, the Gholson's, shared with Congressman Wittman the creative ways they have generated revenue streams from their goats, including goat milk, goat yoga, and bottle feeding events.

The tour then went to Gauthier Vineyard in New Kent, which makes it's wines from 100% Virginia grown grapes. The veteran owned family farm is very proud of the facilities they have added to the property, which have made it a very attractive venue for event hosting.

Finally, the tour stopped at Davis Produce in Lanexa where, in addition to talking Virginia Tech football, Congressman Wittman was able to discuss the wide array of conservation methods being employed on the farm, as well as research projects being conducted on the property by land grant universities.

Farm Credit always appreciates that Congressman Wittman is able to take time out of his very busy schedule to sit down with those working in agriculture to hear their concerns and represent those concerns in Washington.

Farm Credit sponsored, attended, and donated water to the Virginia Soil and Water Conservation District Annual Meeting, held the end of November in Norfolk, VA.




#### **Hanover Ag Day**

#### **Summer Intern**

#### **Tanner Wise**

I worked for Colonial Farm Credit this summer as a Loan Officer Intern, learning how Colonial best serves its customers through rural finance. Before my internship, I was unaware of the extent of services that Colonial provided to the public, but I was aware of what Farm Credit was in general. Growing up on a fifth-generation family farm that consists of beef cattle, dairy cattle, sheep, goats, laying hens, meat broilers,

and guardian dogs in Buckingham County, Virginia, allowed me to be exposed to the Farm Credit name for years. Since I was eligible until college, I have shown livestock and saw Farm Credit sponsoring livestock shows and other agricultural events. I became familiar with some services Farm Credit provides to the public through employees I've networked with and became friends with over the years, but I honestly did not know much more than the basics about Farm Credit. Becoming a Loan Officer Intern allowed me to appreciate the extent of Farm Credit's services to the public and their contributions to the success of rural communities and agribusinesses.

I was ecstatic when I learned that Brian Wathen, the other Colonial Farm Credit Loan Officer Intern I worked alongside, and I would be traveling to Columbia, South Carolina, to the Farm Credit Basics for Interns conference, a prime networking and learning opportunity. This conference was led by Ronnie Hucks, the AgFirst District Learning Liaison, who discussed vital details about the lending process, as well as the mission and goals of the AgFirst Farm Credit Bank. Learning more about AgFirst helped me better understand the relationship between the district banks and associations, a complicated concept to grasp when I started my internship. Networking with other Farm Credit interns and AgFirst employees allowed me to understand their backgrounds better and what they desired to obtain from their experiences as Farm Credit employees. Everyone's backgrounds and previous experiences were quite divergent from each other and my own. Networking allowed me to understand that you don't necessarily have to have agricultural knowledge to work and contribute to Farm Credit's missions and goals. When talking with folks about why they wanted to intern or work for Farm Credit, they all shared the same mission of wanting to help farmers and rural communities to the best of their abilities, allowing me to understand that we are all on the same team even though we don't necessarily see each other face-to-face all that often. As this conference continued and ended, coworkers became professional and personal friends I would most likely meet again no matter what kind of agricultural job I would end up in.

Additionally, I am grateful to have worked alongside the other Loan Officer Intern, Brian Wathen, and attended other events, such as the Agricultural Exposition in Virginia Beach, Virginia. Attending the Virginia

Agricultural Exposition allowed me to understand better how truly diverse Virginia agriculture is and how we need these businesses to best contribute to the success of agriculture from around the state. At my home branch in Farmville, I had the opportunity to learn about local "concepts" such as the areas served, the most popular types of services to offer in certain areas, and understanding the specific demographics and backgrounds of certain areas we serve.
